Leading through research

Queen Mary is one of the UK's leading research-intensive universities. You will be taught by world-class academics whose research directly informs our wide range of postgraduate programmes. It is this environment that makes Queen Mary such an exciting place to undertake your postgraduate study.

Innovative research and teaching

Working closely with industry, government, business, communities and charities, the outcomes of our research are felt around the world, from the communities of east London to the favelas of Rio de Janeiro.

- Queen Mary was ranked fifth in the UK for the quality of research outputs (4* and 3*) in the Research Excellence Framework (latest REF, 2014).

Russell Group

Queen Mary is a member of the Russell Group, the 24 leading universities in the UK. This distinction recognises our commitment to delivering world-class research, teaching and learning.

A history of social justice

Queen Mary has its roots in four historic institutions that were founded to help the less privileged.

At a time when women and working-class communities faced extreme barriers to education, the People's Palace invited people from all backgrounds to study together, and Westfield College was the first residential college in London for women.

The London Hospital Medical College and St Bartholomew's Hospital Medical College were founded in 1785 and 1843 respectively, to improve the health of impoverished communities in the City and east London.

These founders aspired to create places where everyone would have access to the same opportunities in education, recreation and culture, regardless of background.

Mile End

Set alongside the historic Regent's Canal, our Mile End site is one of the largest residential campuses in the city and home to our new £39m Graduate Centre. Most of our postgraduate taught and postgraduate research students across the humanities, social sciences and science and engineering are based here.

Lincoln's Inn Fields

Most of our postgraduate law students are based at our Lincoln's Inn Fields campus in Holborn, the historic legal centre of London. Located in Zone 1, Lincoln's Inn Fields is near to Covent Garden, famous for the performing arts.

Whitechapel

Many of our postgraduate taught and postgraduate research medicine and dentistry students are based on our Whitechapel campus, next to the Royal London Hospital. Whitechapel is a vibrant area, famous for its street markets, art, culture and food. The campus has a strong sense of community with its own library, and state-of-the-art labs at the Blizard Institute.

West Smithfield

Our West Smithfield campus in Farringdon includes St Bartholomew's Hospital (Barts) and the West Smithfield Medical Library, and is home to cardiovascular, cancer, epidemiology and public health research facilities. Some of our postgraduate taught medical students are based here.

Charterhouse Square

We have a campus at Charterhouse Square for postgraduate taught and postgraduate research medical students. Close to the Barbican in the City of London, this is home to the Barts Cancer Institute, the William Harvey Research Institute and the Wolfson Institute of Preventive Medicine. It's also near to the Barbican Arts Centre, the Museum of London and other famous London landmarks.



Accommodation

Queen Mary provides accommodation for postgraduate students across our campuses. We can also provide advice on a range of alternative housing, such as renting, private halls or homestay.

Aspire Point, opened in September 2018, is home to 445 Queen Mary postgraduate students. With stunning views over London and the 2012 Olympic Park, Aspire Point provides affordable living and study space in Stratford, east London. We also have an additional 300 rooms for postgraduate students, available in halls owned by our preferred partner providers. These halls are for students of all disciplines apart from medicine and dentistry students, who have their own dedicated halls of residence.

We will help you every step of the way from supporting your application, helping you with practical arrangements such as visas, funding and accommodation, and making sure you have the necessary English language skills.

Support services

Pre-masters graduate diplomas

Our pre-masters programmes are for international and EU students who do not meet the academic and/or language requirements for masters study, or those who want to switch disciplines from undergraduate to postgraduate. They give you the academic, language and study tools needed for a full degree, including subject-specific knowledge, research skills, academic writing and speaking, and study skills.

We offer two pre-masters programmes: Graduate Diploma in Economics and Finance and the Graduate Diploma in Humanities and Social Sciences. Both our pre-masters programmes are taught at our Mile End campus. For more information, visit: qmul.ac.uk/premasters

Pre-sessional language programmes

Our pre-sessional programmes are for international and EU students who want to improve their English language and academic study skills before enrolling onto their chosen postgraduate degree. World class sport and facilities

Students' Union

Many of our masters students go on to PhD study with us. Our academics supervise a very broad range of thesis topics. Through close individual supervision and a substantial schedule of research training, you will be supported in both completing your project and developing as an independent researcher.



After getting my masters degree, I knew I wanted to explore more the research world. Going for a PhD seems the natural continuation of my chemistry studies. London – and Queen Mary in particular – offered the additional opportunity to study in an international and research-focused institution.

My PhD experience at Queen Mary has been challenging and exciting. PhD students get to work in a highly motivational environment. The effort we put in our research projects usually pays off by having our work published in scientific journals or by going to international conferences to show our research. I attended the international co-ordination chemistry conference in Japan and it was an amazing experience!

The best thing about studying here is definitely the multicultural and vibrant environment. If at times doing a PhD can feel stressful and demanding, I know I can always find the support I need from my supervisor and my colleagues here at Queen Mary.

Funding

We want to attract the best students to Queen Mary, regardless of their financial situation. Every year we offer a range of scholarships for academically excellent students.

In 2018/19, we awarded 60 Queen Mary scholarships worth a total of £1,100,000 to postgraduate taught students across science and engineering, economics and finance, and law. We awarded over 1,000 Queen Mary scholarships worth a total of over £9m to postgraduate research students

We also co-funded 85 Chevening and five Commonwealth Scholarships, which are specifically for international students.

There are a number of funding options available to help you finance your postgraduate study. These include a package of competitive Queen Mary scholarships in a range of subject areas, as well as external sources of funding.


Funding for international students

Our partnerships with external funding organisations such as Chevening, the Commonwealth Scholarship Commission and numerous governments around the world mean that we can support our international students through scholarships and funding.

Postgraduate Masters Loan

The Government's Postgraduate Masters Loan offers up to £10,906 per programme to English students or EU nationals studying in England. International students are not eligible for this loan.

The loan is available for any full or parttime taught masters programme as well as Masters of Research (MRes), though you won't normally be eligible if you already hold a masters degree or higher-level qualification. Separate loans are available if you normally live in Scotland, Wales or Northern Ireland. Loan amounts and criteria differ; for further information visit Student Awards Agency Scotland, Student Finance Wales or Student Finance NI.

Postgraduate Doctoral Loan

You can borrow up to £25,000 with the Government's Postgraduate Doctoral Loan. It is available for any taught or research-based postgraduate doctoral qualification, including part-time and distance learning. If you already hold a doctoral degree, you won't normally be eligible for this loan and other eligibility criteria will also apply.

Entry requirements

Most of our masters programmes require an upper second class Honours Degree or equivalent in a related subject.



Our PhD programmes usually require a minimum of an upper second class Honours Degree or equivalent in a related subject. Some PhD programmes may require a postgraduate-level qualification for entry.

Law conversion programmes

The Senior Status LLB (two years) is a qualifying law degree suitable for non-law graduates. It is an accelerated version of the

traditional three-year route and is popular with students considering a career in law or with an academic interest in the subject.

Fast-track medicine programmes

Our Graduate Entry Medicine MBBS (four years) is designed to be a fast-track route for graduates who obtained good degrees in science or health-related subjects. The first year of study is based on the first two years of the five-year MBBS programme.

2 Changes to our programmes

We will aim to deliver your programme so that it closely matches the way in which it has been described to you by Queen Mary, especially at the point that you accept your offer. However, it is important to understand that there are circumstances in which we may subsequently change aspects of your programme. Our programmes are delivered within a dynamic, academic community by staff who are actively engaged in research. In this context, we might make changes so that our students can learn from the latest academic research. We also value student feedback and provide regular opportunities for our students to comment on the content of their programme. We may therefore alter your programme in response to this dialogue with current students. Other circumstances which can lead to changes include: staff changes, which can lead to new modules being offered, modules being withdrawn, or a change to who teaches the programme; changes made in response to new requirements from external professional or statutory bodies; or changes to the way in which universities are funded, which might lead to changes in the availability of some student services, for example.

In the unlikely event that we discontinue a programme of study, or change it significantly before it begins, we will inform applicants holding an offer of a place at

the earliest opportunity and will endeavour to offer a suitable alternative programme at Queen Mary. We will also ensure that these changes are reflected on our website as soon as possible.

3 Liability for damage to person or property
